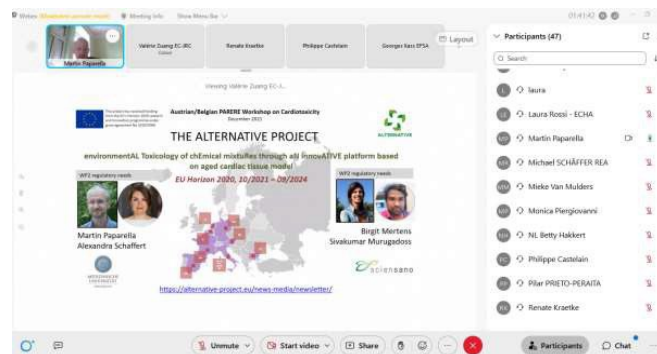
ALTERNATIVE presented at health promotion event in Turin

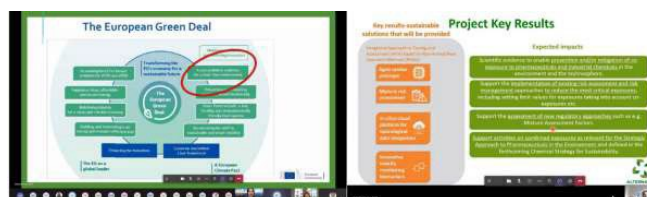


ALTERNATIVE presentation on AOPs for cardiotoxicity at 1st SAAOP Symposium
