Editorial

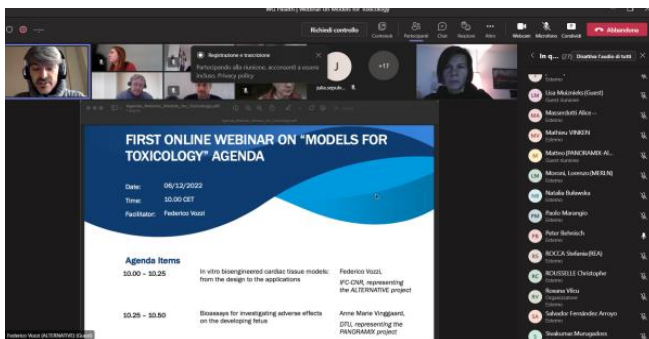
Dear reader,
